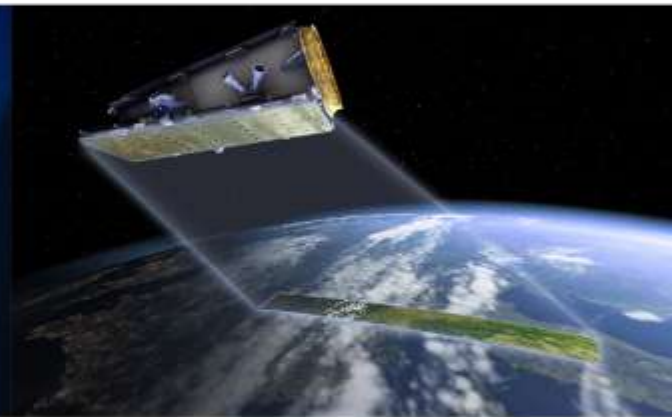

## Send Business Centre, Send (nr. Woking), GU23 7EF

- [Send Business Centre](#) offers serviced/ managed office accommodation and high-tech creative studios.
- Services include: 1000 mbps superfast broadband (with 1 GB circuit installed for faster speeds when required), full VOIP telephony, data storage, meeting rooms, self-storage and warehouse/ industrial units (750-10,000 sq ft), 24hr access, security/ CCTV and free parking.
- The centre has built a prototype sound studio, and intends to roll out 12 more along with recording booths, live rooms and green rooms, as part of its vision to develop a wider [digital creative business hub](#).
